- <u>MBTA Community Zoning</u>: Wednesday, February 16, 2022 (12-2pm; Zoom). Register here for this program to discuss the <u>draft guidelines</u> issued by the Department of Housing and Community Development (DHCD) for compliance under new <u>Section 3A of the</u> <u>Massachusetts Zoning Act</u>. These guidelines were recently submitted for public comment (comments due March 31, 2022) and address the requirement for as of right multi-family housing in at least one zoning district in so-called MBTA communities.
- <u>20<sup>th</sup> Annual Municipal Law Conference 2022</u>: Wednesday, March 16, 2022 (9am-5pm; Zoom). Register on the <u>MCLE website</u> for the annual Municipal Law Conference covering the latest developments in municipal law. MMLA and MMA co-sponsor this annual program, which provides essential updates on recent developments from the Legislature, government regulators, and the courts on many areas of public sector law. This year's program will address new and evolving developments regarding the public records, open meeting, land use and zoning, environmental laws, public employment law, cybersecurity and data breaches, and 2<sup>nd</sup> Amendment, home rule and gun regulation. It will also feature a presentation on administrative law.

## **Recent Decisions of Note:**

- <u>City of Newton v. Commonwealth Employment Relations Board (Massachusetts Appeals</u> <u>Court)</u> – This decision contains a good discussion about the obligation to bargain over fitness for duty examinations, which in this case involved a psychological fitness for duty examination.
- <u>Boston Clear Water Co., LLC v. Town of Lynnfield (Massachusetts Appeals Court)</u> In this decision, the Massachusetts Appeals Court held that a local conservation commission's failure to conduct a hearing within 21 days after an applicant's notice of intent, under the Wetlands Protection Act and its town bylaw, caused it to lose its authority over a proposed project and forfeit its right to enforce the bylaw, enabling the Department of Environmental Protection's superseding order to control.

#### MMLA Committee Spotlight: Legislative Committee

For the inaugural edition, the MMLA Minute will spotlight the MMLA's Legislative Committee, which is chaired by Jillian Jagling:

The Legislative Committee prepares recommendations for legislation and reviews bills that are brought to its attention in order to make recommendations to the MMLA Executive Board on whether to support, oppose or take no position. When making recommendations and reviewing bills, the Committee considers a review criteria that includes whether the matter affects cities and town generally, whether any other organizations (such as the Massachusetts Municipal Association) have taken a position, whether the legislation purports to solve a problem faced by municipalities, add to municipal costs, impact collective bargaining, affect public health, safety or welfare, or increase or decrease the flexibility municipalities have in dealing with local issues, and whether the legislation would have any unintended consequences for municipalities which have not been foreseen by the drafters.

The Legislative Committee prepared the 2021-22 Legislative Package in February 2021, which includes a number of refiled and new bills that the Committee recommended, including for example, an act providing for alternative delivery of infrastructure projects, an act relative to authorizing governmental bodies and other approved parties to use shared legal representation

and consultants, an act relative to the effective enforcement of municipal ordinances and bylaws, and an act relative municipal authority in public rights of way.

The Committee is currently also tracking bills concerning the Open Meeting Law, including legislation impacting town meetings and municipal elections, and will be discussing legislation on Body Worn Cameras at the next meeting. The Committee will also be looking towards and strategizing regarding the next legislative session and any anticipated municipal modernization legislation that might be included.

MMLA members can submit requests for the MMLA to take a position on bills, which are reviewed by the Executive Board and may be referred to the Legislative Committee for consideration and recommendation on whether MMLA should support, oppose or take no position. MMLA members are also invaluable resources to the Legislative Committee, which encourages members to be involved and share information that they have on legislation, regulations and other public agency matters impacting municipalities.

#### Other News and Reminders:

- At its January 2022 meeting, the MMLA Executive Board voted:
  - To subscribe to <u>InstaTrac</u>, a legislation monitoring service, which will aid the MMLA and its Legislative Committee in tracking the latest legislative developments on Beacon Hill.
  - To join the <u>Massachusetts Nonprofit Network</u>, an organization comprised of Massachusetts nonprofit organizations. As you may recall, the MMLA is organized as a 501(c)(3) nonprofit organization.
  - To accept the recommendation of the Amicus Committee and authorize the Amicus Committee to file an *amicus curiae* brief in the matter of <u>Armstrong v.</u> <u>Theoharides</u>, which is currently pending at the Massachusetts Supreme Judicial

Court (SJC-13210). This appeal concerns two cases challenging the City of Boston's Downtown Waterfront Municipal Harbor Plan and has the potential of impacting harbor management plans statewide.

- The MMLA is assembling a Working Group of MMLA members to review DHCD's guidelines under Section 3A of the Zoning Act and work on the MMLA's comments to these guidelines (before the March 31, 2022 deadline). All MMLA members are welcome and invited to participate. - On January 31, 2022, the MMLA provided its Annual Municipal Law Update at the Massachusetts Municipal Association Annual Meeting, which was held virtually. Attendees were brought up to speed on important developments in municipal law as they relate to Massachusetts cities and towns, in areas such as land use and zoning, municipal finance and taxation, public governance, and other areas with significant developments.
